1. Introducción

Para determinar el desempeño de resistencia al fuego de una muestra de techo cuando se prueba de acuerdo con la sección 4 de AS 1530.4:2014: Métodos para ensayos de fuego en materiales, componentes y estructuras de construcción Parte 4: Ensayos de resistencia al fuego de elementos de construcción.

El lado especificado de la muestra presentada se expuso a una curva de tiempo-temperatura según lo dictado por la cláusula 2.11 de AS 1530.4 durante un período de 60 minutos en condiciones sin carga.

La prueba se realizó el 6 de diciembre de 2023.

2. Muestra de prueba

La muestra se recibió el 23 de noviembre de 2023 y se almacenó en el laboratorio hasta el 6 de diciembre de 2023. Durante

Durante el almacenamiento de la muestra, se midieron y registraron la temperatura y la humedad del laboratorio.

dentro de un rango de 11 °C a 19 °C y de 42 % a 71 %, respectivamente. La muestra se instaló en

06 de diciembre de 2023, y la prueba se realizó el 06 de diciembre de 2023.

Las dimensiones totales de la muestra fueron 1000 mm de largo por 1000 mm de ancho y 85 mm de espesor. La placa frontal...

Era de bambú y tablero de fibra de madera, la placa posterior era un rollo de chapa de acero coloreado, el material del núcleo era PU Tablero de espuma. La estructura principal de la muestra era un tablero de fibra de bambú y madera de 9 mm de espesor + poliuretano.

Tablero de espuma + rollo de chapa de acero coloreada de 0,5 mm de espesor de la cara expuesta, el espesor total fue de 85 mm.

3. Equipos de instrumentación y medición

El horno tenía unas dimensiones interiores de 4,2 m de largo por 3,0 m de ancho por 1,5 m de profundidad y catorce termopares.

Distribuidos sobre un plano a 100 mm de la superficie de la construcción de prueba, se proporcionaron para monitorear la temperatura de la atmósfera del horno.

Se instalaron sensores de presión dentro del horno para monitorear la presión atmosférica del horno.

Se proporcionaron siete termopares para monitorear la temperatura de la superficie no expuesta de la muestra,

Se disponía de un termopar móvil para medir las temperaturas en la superficie no expuesta de la muestra.

4. Procedimiento de prueba

La prueba se realizó de acuerdo con el procedimiento especificado en AS 1530.4:2014, sección 4.

La temperatura ambiente del área de prueba fue de 15 °C al comienzo de la prueba con una variación de +1 °C durante la prueba.

El horno se controló de manera que la temperatura media del horno, la desviación de la temperatura media del horno

La temperatura y la uniformidad de la distribución de la temperatura cumplieron con el requisito de AS 1530.4:2014.

Se utilizaron dieciséis termopares de horno para determinar la temperatura media del horno.

La presión del horno se controló para cumplir con los requisitos de AS 1530.4:2014, Cláusula 2.11.3.

El horno se operará de tal manera que se establezca una presión de 20 Pa en una posición 100 mm por debajo del parte inferior de la muestra de prueba por encima de la atmósfera del laboratorio. 5 minutos después del inicio de la prueba, la presión del horno no debe desviarse en más de ± 5 Pa, y a partir de los 10 minutos no debe desviarse en más de ± 3 Pa.

Se utilizaron discos de algodón y calibradores de separación para determinar la integridad. La llama sostenida en la parte no expuesta...

6. Criterios de desempeño (AS 1530.4:2014, Cláusulas 2.13.2 y 2.13.3)

Integridad

Se considerará que se ha producido una falla en relación con la integridad cuando se evalúe de la siguiente manera:

1) Disco de algodón

La almohadilla de algodón en su marco se aplicará contra la superficie de la muestra de prueba sobre la grieta, fisura o en llamas durante el examen, hasta la ignición del disco de algodón (definido como brillante o en llamas) o durante un máximo de

Años 30.

2) Calibres de separación

Los medidores de espacio se utilizan para evaluar el tamaño de cualquier abertura en la superficie de la muestra de prueba en intervalos de tiempo, que se determinará por la tasa aparente de deterioro de la muestra.

a) Se puede pasar un calibre de 6 mm a través de la muestra de modo que el calibre sobresalga hacia el interior del horno.

3) Flaming

La permanencia de llamas en la superficie no expuesta durante 10 segundos o más constituye una falla de integridad.

Aislamiento

Se considerará que se ha producido una falla en relación con el aislamiento cuando se mida mediante termopares en el superficie no expuesta, se considera que la muestra ha fallado cuando:

1) la temperatura media de la cara no expuesta de la muestra de prueba excede la temperatura inicial en más de 140 K; o

2) la temperatura en cualquier punto de la cara no expuesta de la muestra de prueba excede la inicial la temperatura en más de 180 K; o

3) Cuando se produce un fallo de integridad.

7. Conclusión

Durante el período de calentamiento de 60 minutos, no hubo llamas ni aberturas en la cara no expuesta del muestra, el calibre de espacio de Ø6 mm no pudo penetrar la muestra, la almohadilla de algodón no se encendió durante el Prueba de almohadilla de algodón, la integridad de la muestra alcanzó los 60 min; al final de los 27 min, el aumento de temperatura promedio en la superficie no expuesta de la muestra fue de 72,8 K y el aumento de temperatura máximo fue de 188,2K, el aislamiento de la muestra alcanzó los 26min.




Figura 1, Estructura de la muestra






Figura 3. Curva de temperatura/tiempo del horno real frente a temperatura/tiempo del horno estándar




Figura 4. La temperatura media y máxima aumenta en la superficie no expuesta de la muestra.




Figura 5, Curva de presión/tiempo del horno


